After winning a few skirmishes against powerful Spanish forces, Hidalgo and his group were defeated near Guadalajara and were forced to retreat. By June 16, 1811, many of Hidalgo’s conspirators were detained and executed. On July 30, 1811, Padre Miguel Hidalgo Y Costilla faced a firing squad, and the Independence Movement that he advocated was defeated momentarily.

Mexico would have to wait eleven years, many of them filled with wars, by despotic Mexican rulers and political unrest until 1821 when Mexico and also Texas would be free from Spanish rule. Therefore, not only Mexico and its people were freed from the mother country, but so were the Tejanos, many of whom had fought and died in support of Padre Miguel Hidalgo Y Costilla and his “El Grito” of September 16, 1810. There were specifically two skirmishes that occurred on Texas soil: 1.) one was the “de las Casas Revolt” of 1811 in San Antonio where the rebels attempted to oust the then Spanish Governor of Texas, Manuel Salcedo, and 2.) the second was the Battle of Medina where one thousand Tejanos perished in support of Hidalgo’s independence efforts. That is why Tejanos/Texans still celebrate this historical event of “El Grito” of September 16, 1810, in present day Texas. They are paying homage and remembrance to those brave Tejanos who paved the way to what later on led to the Battle of the Alamo of 1836. One man’s quest for freedom belongs to the entire human race. “El Grito” of September 16, 1810, has now transcended national boundaries and has become “El Grito” of freedom for all mankind.

The Pastry War (Mexico Vs. France, 1838-1839)

Because Mexico had growing pains after getting its independence from Spain in 1821, there were successive governments replacing one another. There were many lawless acts and fighting in the streets. French citizens living in Mexico had businesses and investments ruined. During this period of strife, a pastry shop owned by a Frenchman, Monsieur Remontel, was ransacked by drunken army soldiers. In the 1830s, several French citizens demanded reparations from the Mexican government. One of these was Monsieur Remontel. By this time, Mexico owed a great debt to European nations and it appeared that it was not going to be paid. Using this demand as an excuse, France blockaded the main port of Veracruz. Mexico declared war and French troops attacked and captured Veracruz. The Pastry War marked the return of Antonio Lopez de Santa Anna. He lived near the city when war broke out and he rushed to lead its defense. The Mexican defenders lost, but he emerged a hero because he lost one of his legs during the fighting. Finally Mexico agreed to pay the full amount demanded by France and the French withdrew. Santa Anna’s leg was buried with full military honors.



Google Tip

You should always be aware that a name can appear differently in different sources. For example, “Andres Medrano” might appear in an article. On the other hand, “Medrano, Andres” might appear in a county record. For that reason, genealogists should always be sure to search for at least three variations of an ancestor’s name. The three ways I might search for Andres Medrano might be “Andres Medrano” (note the quotes), OR “Medrano, Andres” Or “Andres * Medrano”. The asterisk indicates that there might be a character or string of characters between Andres and Medrano, ex., Andres Jose Medrano.

Fugitive For Nine Years Is Captured

Nine years ago Reuben Cortez was indicted jointly with Juan Salinas for the murder of Fernando Medrano at Harlingen.

Cortez fled across the Rio Grande and was not apprehended by officers. Salinas was arrested and later sentenced to 30 years in the penitentiary.

After being free for nine years, Cortez is now in the Cameron county jail facing his old murder indictment. He was arrested Saturday night by E. W. Anglin at Harlingen.
